RESOLVED, that the budget for the Silver Creek Central School District, Chautauqua County, New York, for the fiscal year commencing July 1, 2019 and ending June 30, 2020, as presented by the Board of Education, is hereby approved and adopted in the amount of \$24,845,381 and the required funds therefore are hereby appropriated and the necessary real property taxes required shall be raised by a tax on the taxable property in said District to be levied and collected as required by law.

PROPOSITION NO. 2 -  
**VEHICLE PURCHASE FROM THE CAPITAL RESERVE FOR VEHICLES**  
(Vote YES or NO)

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education (the "Board") of the Silver Creek Central School District (the "District") is hereby authorized to purchase two (2) large (a 66-passenger bus at \$105,724.12 and a 66-passenger bus at \$114,710.36) buses and one (1) small (24-passenger bus plus one wheelchair at \$66,509.46) school bus for use in the transportation program of the District, at a total cost of \$286,943.94, and that the aforesaid total cost shall be funded from the funds from the Capital Reserve for Vehicles of the District, as established pursuant to approval by the District's voters on May 19, 2015, and BE IT FURTHER RESOLVED, that this authorization to fund the purchase of two (2) large and one (1) small school buses for use in the transportation program of the District using reserve fund monies shall have no effect on the tax rate for the 2019-2020 school year.
